Submission Regulations

Competition theme: HARMONY

Celebrating the hope that the differences among people all over the world can be harmoniously resolved

Number of submissions: Maximum of four (obverse + reverse of a single medal counts as two submissions)

Individual entry regulations:

Size maximum single medal: 100(h) x100 (w)mm x depth of less than half the shortest side of the medal

multiple-part medal: $100(h) \times 100 (w)$ mm coin submission: $50 \times 50 \times 10$ mm

Material: Any single material or combination of materials, **excluding organic materials**

Edition: Work should be reproducible in limited edition, or in variations

Submission Deadlines & Jury Procedure

1. **By June 30, 2024**: Artist's Digital submission of all entried by e-form

- In the event the customs office sends notice of duty tax due for releasing the work, the work cannot be entered into the competition and will be returned to the sender.
- See the mailing instructions. Work will be returned via the Postal Service. Any damage or loss of work during shipping, both receiving and returning, is not the responsibility of the Medialia Gallery or New Approach.

Mailing Instructions

Mailing:

- Address will be supplied after juried selection.
- Send via postal service, please specify: COMPETITION ENTRY
- Advisement: do not insure, and indicate a work value of \$10. With insurance, the package will be stopped in customs, and incur customs fee.

Packing:

- Send the work in a reusable box.
- Work will be returned in the same box with packing.
- Pack each piece with corresponding artist and work information
